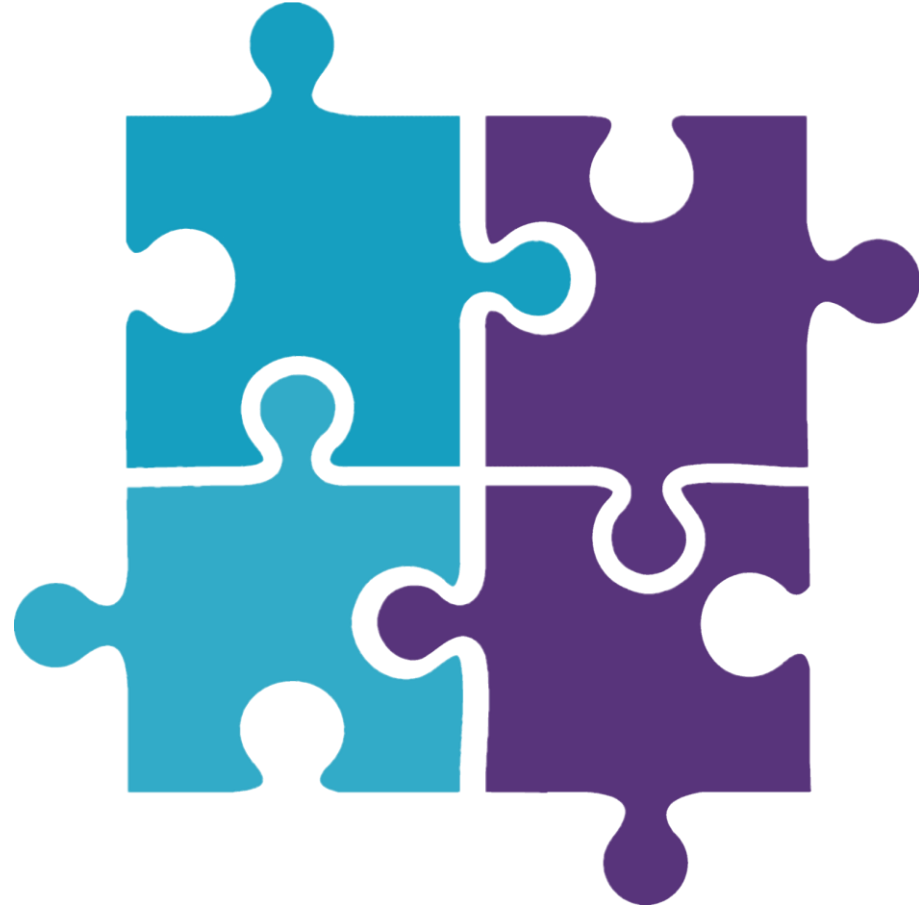

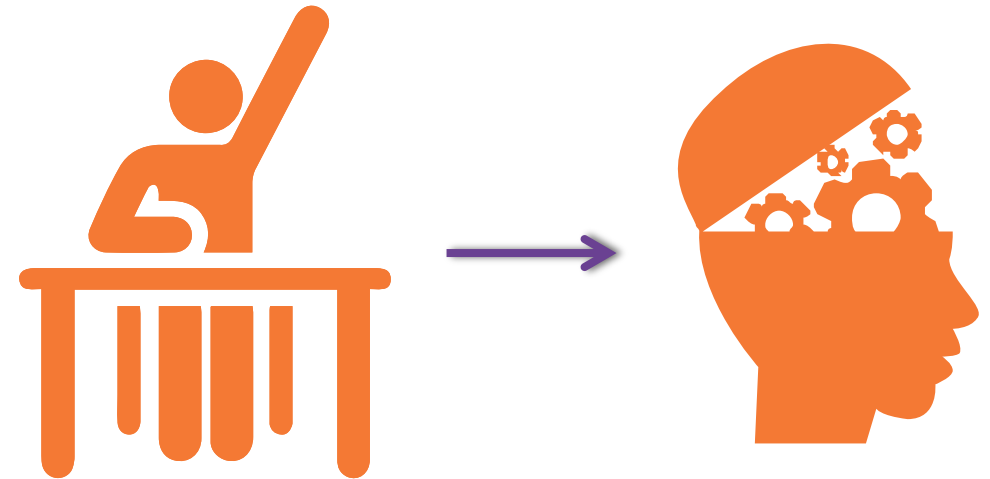


# 1) Understanding CME Team Due Diligence on Sponsorship:

---

- Intricacies affiliates must navigate to offer accredited education
- Credit granting requirements and policies
- Your concerns

- *We need your input!*
  - *Examples of what you are struggling with*
  - *What doesn't make sense?*
  - *Share your brilliant ideas on making it better!*





## 2) Shaping Processes and Policies

---

- Goal - Keep things simple!
- Concept areas:
  - Create an online application
  - Develop FAQs and Best Practices
    - Clear and understandable!
  - Ways to offer our support and guidance with questions
- *We need your input!*
  - *Examples of what would make it easier for you*
  - *Areas you need direction in*



### 3) Shaping Platforms

---

- Technology considerations
- Systems must talk to each other behind the scenes  
...and make sense
- *We need your input!*
  - *Examples of where you may have had difficulties*
  - *What functionality would you like?*



## 4) Roll out

---

- Details delineated and clearly communicated, such as:
  - When you must do something
  - What you need to do
  - How you to do it
  - Fees



- *We need your input!*
  - *Best ways and formats to inform you?*
    - *i.e., email, website*
    - *i.e., webinars, tutorials, documents, templates*
