COMMISSION ON OSTEOPATHIC COLLEGE ACCREDITATION Thomas A. Cavalieri, DO, FACOI, Chair

This report is for the period from June 1, 2012 through May 31, 2013. During this period the AOA Commission on Osteopathic Accreditation (COCA) met three times: September 8-9, 2012; December 1-2, 2012; and May 4-5, 2013.

COCA meeting September 2012

The COCA met on September 8-9, 2012 at the O'Hare Hilton Hotel (Chicago, IL). On September 6, an orientation session was conducted for one newly appointed COCA member. Accreditation action items for the meeting agenda included:

- ☐ Received the report in executive session on AOA and AACOM discussions with the Accrediting Commission on Graduate Medical Education (ACGME) to develop a unified accrediting system for graduate medical education activities;
- Received oral remarks from AOA President Stowers regarding research strategies in the profession;
- Received and discussed a draft report of Blue Ribbon Commission on the future of osteopathic medical education with two representatives of the Blue Ribbon Commission.

COCA - Executive Committee (COCA - EC)

August 2012

September 2012 Report – there was no report from the Annual Report Review Committee at this meeting.

COM Accreditation Appeal Panel

There were no appeals heard during this year.

Committee on College Accreditation Training (CCAT)

September 2012 -

The committee chair met with staff and CCAT members via teleconference on August 23, 2012 to review the draft agenda and propose potential speakers for the CCAT workshop, scheduled for Saturday/Sunday, November 10-11, 2012, in Washington, DC.

December 2012 Report -

The CCAT held its Evaluator Training Workshop on November 10-11, 2012, at the DoubleTree by Hilton Hotel – Washington, DC-Crystal City in Arlington, Virginia. Themed, "Evaluation Goals in 2012," the program focused on evaluating assessment outcomes and choosing the right communication approach to deliver assessment results. The workshop had a total of 73 registrants, including six COCA members, four CCAT members, and 2 guest speakers.

Participants attended four plenary sessions including:

- 1. Examining "Best Practices" in Outcomes-based Assessment: Alignment? Analysis? Action? Accreditation? Speaker, Amy Driscoll, PhD, Consulting Scholar, Carnegie Foundation for the Advancement of Teaching and the New England Resource Center for Higher Education, provided techniques on "best practices" in outcomes-based assessment. Participants interacted with examples of "best practices" from the perspectives of both educators and accreditors for a deep understanding of the components of an assessment cycle.
- 2. E-accreditation and Overview Speaker Konrad C. Miskowicz-Retz, PhD, CAE, Director, Department of Accreditation, AOA and Thomas Levitan, MEd, Vice President for Research and Application Services, AACOM, discussed electronic media and its application to both organizations. Dr. Miskowicz-Retz addressed the future transition of COCA to E-accreditation, its benefits, and what can be expected by both evaluators and COMs. Dr. Levitan addressed the future transition of AACOM to electronic media and its benefits related to data compilation and presentation for COMs, COCA and the public.
- 3. **Frequently Missed Standards** Speaker Kenneth J. Veit, DO, MBA, FACOFP, COCA Commissioner, Senior Vice President for Academic Affairs and Dean, Philadelphia College of Osteopathic Medicine, addressed standards often missed by evaluators with the goal of examining divergent interpretations and reaching consensus.
- 4. What's New/What's Coming GME Standards, Standards Survey and Work Plan of Standards Review Committee Speaker Konrad Miskowicz-Retz, PhD, CAE, provided an update on the new and revised standards. Speaker Andrea Williams, MA, Director, Division of Predoctoral Education, AOA, discussed the current status of the standards survey. Speaker Ronnie B. Martin, DO, FACOFP, COCA Commissioner and Chair, Standards Review Committee, addressed the changes to the Standards from the committee's perspective.

The afternoon of Day One of the program featured six breakout sessions that included: a session for preclinical and clinical evaluators that focused on reaching consensus on Faculty Adequacy Models; a session for preclinical evaluators that focused on research adequacy and faculty development program; a session for clinical evaluators that focused on clinical adequacy, GME adequacy, and core competencies and phone interviews at distant clinical sites; a session for student services that focused on the nondiscrimination statement, off campus policies, FERPA and Standard 5.5; a session for team chairs that focused on effectively delivering news, which was presented by guest speaker, Dorothy Pirovano, APR, CEO, Public Communications, Inc.; and a session for new evaluators that focused on training for new evaluators.

May 2013 Report -

There was no report from the Committee on College Accreditation Training at this meeting.

COCA Standards Review Committee (SRC)

September 2012 Report – there was no SRC report at this meeting

December 2012 Report -

The Standards Review Committee met by teleconference on October 2, 2012. The discussion by the SRC during the teleconference resulted in the following topics being proposed for a work plan:

- □ Priority One: Standard Two: Governance, Administration and Finance review and revise domain with content emphasis on standards that address COM leadership and identification of the differences in the institutional accreditation concerns vs. programmatic accreditation concerns;
- □ Priority Two: Standard Eight: GME Outcomes (effective July 1, 2013) define terms in 8.3 and 8.5; review and determine reporting and monitoring and assigning standards to particular members of site visit team for review;

- □ Priority Three: SOMA Request Gender identity review current language in standards; review recommendations from Student Services Evaluators; review with legal counsel.
- ☐ Priority Four: Standards Survey review results of standards survey and make recommendations for changes based on results;
- □ Priority Five: AACOM "parking lot" Review recent letter from AACOM with recommendations from Deans' Retreat in November 2012 of current issues they would like to be reviewed by the Standards Review Committee and the COCA.

May 2013 Report -

At the December 1-2, 2012 meeting of the COCA, several topics were proposed for consideration by the Standards Review Committee in order to make proposals to the COCA for changes to the *Accreditation of Colleges of Osteopathic Medicine: COM Accreditation Standards and Procedures.* These topics included:

- Review and propose revisions for Standard One: Mission, Goals and Objectives and Standard Two: Governance, Administration and Finance;
- □ Definition of terms and needed clarification for new Domain Standard Eight: GME Outcomes particularly for 8.3 and 8.5;
- Standard Five: Students language of gender identity changes in this Domain made by SOMA;
- ☐ Issues proposed by AACOM that need review and response by COCA;
- □ 2012 Standards Survey.

A series of teleconferences were scheduled with SRC members to discuss these topics. Teleconferences took place on December 20, 2012, January 14, 2013, February 11, 2013, and March 19, 2013.

A Standards Forum was held on April 6, 2013, at the O'Hare Hilton Hotel, in Chicago, Ill. All COCA stakeholders were invited to attend and participate. In addition to the topics mentioned above, the Standards Forum also discussed a proposal on diversity submitted by the Student National Medical Association. Two representatives from that organization were present for the discussion. AACOM had also presented the SRC with revisions to Standard Six: Curriculum, which were also on the agenda for the Standards Forum.

Forty-six stakeholders attended the Standards Forum. The discussion was as follows:

- □ Proposed changes to Standard One: Mission, Goals and Objectives and Standard Two: Governance, Administration and Finance were discussed. Objection to some of the changes was expressed and new language was offered. This topic will go to the SRC for further discussion and recommendation.
- Definition of terms and language clarification for new Standard Eight: GME Outcomes was discussed. Recommendations from stakeholders will go to the SRC for further discussion and final language will be proposed for COCA decision.
- AACOM proposal for changes to Standard Six: Curriculum was discussed. Responses from stakeholders will be reviewed by the SRC and recommendations will be given to the COCA.
- □ AACOM long standing issues were discussed. AACOM proposed that a Task Force be formed to address these issues made up of AACOM, AOA and COCA members.
- □ Language of gender identity and changes to standards 2.8, 4.3, and 5.3.2 were discussed. Responses from stakeholders will be reviewed by the SRC and recommendations will be given to the COCA.
- Two representatives from the Student National Medical Association made a presentation to the SRC and stakeholders regarding proposed changes to diversity qualification in the Standards. This proposal will be reviewed by the SRC and recommendations will be made to the COCA.

The Standards Review Committee met via teleconference on Monday, April 22, 2013. As a result of this teleconference, the Standards Review Committee decided to make the following recommendations to the COCA:

- 1. Proposed final changes to Standard Eight: GME Outcomes for COCA approval.
- 2. Adopted of all six recommendations proposed by Mr. Wells and reviewed by the SRC as contained in the "Report by David Wells to COCA SRC Regarding Issues Raised by AACOM."

- 3. Proposed changes to Standard One: Mission, Goals and Objectives and Standard Two: Governance, Administration and Finance are presented for COCA review.
- 4. Proposed changes to Standard Six: Curriculum as presented by AACOM are presented for COCA review.
- 5. Proposed changes to Standards 2.8, 4.3 and 5.3.2 are presented to COCA for review and adoption of new language.
- 6. Proposed edits to COCA Standards as presented by the Student National Medical Association are presented with a recommendation for continued study by the SRC.
